It is a voluntary and confidential process in which two or more people meet face-to-face to work out a mutually acceptable solution to the problem. Our mediators are volunteer professionals from the community who receive specialized training in communication skills and conflict resolution. A mediator is a *neutral* third party who does not give advice or decide who is right or wrong.

A mediation can be scheduled at a time that is convenient for you! Fees are based on a sliding scale depending upon your annual income and/or case type.
